1. Decision summary

The Delegated Officer has determined to make amendments to Licence L8190/2007/2. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

2. Scope of assessment

2.1 Regulatory framework

In amending the licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

2.2 Application summary

On 27 July 2025, the licence holder submitted an application to the department to amend Licence L8190/2007/2 under section 59B of the Environmental Protection Act 1986 (EP Act). The amendment is limited only to change the licence holder's name. Licence L8190/2007/2 is held by the Department of Housing and Works (licence holder) for the Intractable Waste Disposal Facility (the premises), located on Crown Reserve No.42001, Lot 73 on Deposited Plan 217902 in Boorabin.

The premises relates to the category and the assessed production/design capacity under Schedule 1 of the Environmental Protection Regulations 1987 (EP Regulations) which are defined in existing L8190/2007/2

3. Consultation

The Licence Holder was provided with the draft Amendment Report on 1 October 2025. Comments received from the Licence Holder on 22 October 2025 have been considered by the Delegated Officer, where the Licence Holder accepted the proposed amendments and waived the remaining comment period.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended licence will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
