1. Decision summary

The delegated officer has determined to make amendments to licence L9189/2019/1. The amendments are administrative in nature therefore they do not alter the risk profile of the premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

The revised licence issued because of this amendment consolidates and supersedes the existing licence previously granted in relation to the premises. The revised licence has been granted in a new format with existing conditions being transferred, but not reassessed, to the new format.

This amendment report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act). The decision report for the existing licence will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the licence, the department has considered and given due regard to its regulatory framework and relevant policy documents which are available at https://www.wa.gov.au/service/building-utilities-and-essential-services/integrated-essential-services/dwer-regulatory-documents

2.2 Application summary and overview of premises

The premises relates to the categories and assessed production / design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing licence L9198/2019/1.

Licence L9198/2019/1 is held by Westmore Corporation Pty Ltd (licence holder) for the Westmore Muchea landfill (the premises), located at 4040 Great Northern Highway, Muchea, being Lot 607 on Plan 409232. This licence is set to expire on 31 December 2025.

On 1 October 2025, the licence holder submitted an application to renew the existing licence. As part of application validation, the delegated officer identified issues with the adequacy and enforceability of the existing licence conditions, which could not be addressed prior to expiry.

On 6 November 2025, the department initiated an amendment to licence. The amendment is limited to extending the licence expiry date to allow sufficient time to process a licence renewal. The renewal process will include a full review of the premises and licence.

3. Consultation
