Interpretation

In this licence:

- (a) the words 'including', 'includes' and 'include' in conditions mean "including but not limited to", and similar, as appropriate;
- (b) where any word or phrase is given a defined meaning, any other part of speech or other grammatical form of that word or phrase has a corresponding meaning;
- (c) where tables are used in a condition, each row in a table constitutes a separate condition:
- (d) any reference in this licence to an Australian or other standard, guideline, or code of practice, means the version of that document in force at the time of granting of this licence;
- (e) unless specified otherwise, any reference to a section of an Act refers to that section of the EP Act; and
- (f) unless specified otherwise, all definitions are in accordance with the EP Act.

NOTE: This licence requires specific conditions to be met but does not provide any implied authorisation for other emissions, discharges, or activities not specified in this licence.

Licence conditions

The licence holder must ensure that the following conditions are complied with:

Waste acceptance

1. The licence holder must only accept onto the premises waste of a waste type set out in Table 1, which does not exceed the corresponding rate at which waste is received, and which meets the corresponding acceptance specification set out in Table 1.

Table 1: Types of waste authorised to be accepted onto the premises

Inert Waste Type 2	5 000 tonnes per annual period	Tyre bales or whole tyres only

Note 1: Additional requirements for the acceptance of controlled waste (including tyres) are set out in the *Environmental Protection (Controlled Waste) Regulations 2004*.

2. The licence holder shall ensure that where waste does not meet the waste acceptance criteria set out in condition 1 it is removed from the Premises by the delivery vehicle or, where that is not possible, stored in a quarantined storage area or container and removed to an appropriately authorised facility as soon as practicable.

Operational controls

3. The licence holder shall ensure that wastes accepted onto the Premises are only subjected to the process(es) set out in Table 2 and in accordance with any process limits described in that table.

Table 2: Waste processing

Waste type	Process(es)	Process limits ¹
	Acceptance and storage prior to disposal	 All unburied waste shall be removed from the Premises by the end of the working day. No waste shall be temporarily stored within 15 metres of the boundary of the Premises.
Inert Waste Type 2	Disposal of waste by landfilling	 Wastes shall be disposed of in a defined trench and within an area enclosed by earthen bunds. No waste shall be landfilled within 15 metres of the boundary of the premises. The separation distance between the base of the landfill and the highest groundwater level shall not be less than 3 metres. The separation distance between any existing or new tipping areas and any naturally occurring surface water body shall not be less than 100 metres. Tyre bales and whole tyres shall be separated from each other by at least 500 mm of cover material. The maximum area being worked at any one time shall be one (1) module/cell.

Note 1: Additional requirements for the landfilling of tyres are set out in Part 6 of the Environmental

Protection Regulations 1987.

4. The licence holder shall ensure that cover is applied and maintained on landfilled wastes in accordance with Table 3 and that sufficient stockpiles of cover are maintained on site at all times.

Inert Waste	Soil	100 mm	Within 24 hours of the waste being deposited
Type 2	3011	1 000 mm	Final cover after completion of waste disposal in each cell

- **5.** The licence holder shall implement the following security measures at the site:
 - (a) erect and maintain suitable fencing to prevent unauthorised access to the Premises:
 - (b) ensure that any entrance gates to the Premises are securely locked when the Premises are unattended; and
 - (c) undertake regular inspections of all security measures and repair damage as soon as practicable.
- 6. The licence holder shall operate and maintain all pollution control and monitoring equipment to the manufacturer's specification or any relevant and effective internal management system.
- 7. The licence holder shall immediately recover, or remove and dispose of spills of environmentally hazardous materials outside an engineered containment system.

Fire control

- **8.** The licence holder shall ensure that an unauthorised fire on the Premises is extinguished as soon as practicable.
- **9.** The licence holder shall ensure that water and other liquid waste that may result from firefighting on the Premises is captured and contained within the Premises.
- **10.** The licence holder shall ensure firefighting equipment stored on site is capable of controlling and extinguishing a tyre fire.

Monitoring

11. The licence holder shall undertake the monitoring in Table 4 according to the specifications in that table.

Records and reporting

- **12.** The licence holder shall ensure that:
 - (a) any person left in charge of the Premises is aware of the conditions of the Licence and has access at all times to the Licence or copies thereof; and
 - (b) any person who performs tasks on the Premises is informed of all of the conditions of the Licence that relate to the tasks which that person is performing.
- **13.** The licence holder must maintain accurate and auditable books including the following records, information, reports, and data required by this licence:
 - (a) the calculation of fees payable in respect of this licence;
 - (b) any maintenance of infrastructure that is performed in the course of complying with conditions 6 and 10 of this licence;
 - (c) monitoring programmes undertaken in accordance with condition 11 of this licence; and
 - (d) complaints received under condition 15 of this licence.
- **14.** The books specified under condition 13 must:
 - (a) be legible;
 - (b) if amended, be amended in such a way that the original version(s) and any subsequent amendments remain legible and are capable of retrieval;
 - (c) be retained by the licence holder for the duration of the licence; and
 - (d) be available to be produced to an inspector or the CEO as required.
- 15. The licence holder must record the following information in relation to complaints received by the licence holder (whether received directly from a complainant or forwarded to them by the Department or another party) about any alleged emissions from the premises:
 - (a) the name and contact details of the complainant, (if provided);
 - (b) the time and date of the complaint;
 - (c) the complete details of the complaint and any other concerns or other issues raised; and
 - (d) the complete details and dates of any action taken by the licence holder to investigate or respond to any complaint.

- **16.** The licence holder must:
 - (a) undertake an audit of their compliance with the conditions of this licence during the preceding annual period; and
 - (b) prepare and submit to the CEO by no later than 28 days after the end of that annual period an Annual Audit Compliance Report in the approved form.
- 17. The licence holder must submit to the CEO by no later than 28 days after the end of each annual period, an Annual Environmental Report for that annual period for the conditions listed in Table 5, and which provides information in accordance with the corresponding requirement set out in Table 5.




Figure 1: Map of the boundary of the prescribed premises

The boundary of the prescribed premises is shown in the map below (Figure 1).
