1. Decision summary

The Delegated Officer has determined to make amendments to Licence L8336/2009/3. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act). The decision report for the Existing Licence L8336/2009/3 will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <https://dwer.wa.gov.au/regulatory-documents>.

2.2 Amendment summary

Suez Recycling & Recovery Pty Ltd currently holds Licence L8336/2009/3 for the operation of the Mindarie Resource Recovery Facility, which is located at Lot 801 on Plan 57533 Pederick Road, NEERABUP, WA 6031 (the Premises).

This amendment is limited to a transfer of Licence L8336/2009/3 from Suez Recycling & Recovery Pty Ltd to Mindarie Regional Council. This transfer was made at the request of Mindarie Regional Council on 9 November 2021.

The assessment of the Licence transfer application is limited to a review of land ownership details to determine if a licence transfer may occur.

The Premises relates to the category 67A and the assessed production capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations). There are no proposed changes to the current approved Premises categories or design capacity.

The obligations of the Licence Holder have not changed in the revision of the Licence and the transfer is limited to:

- Registered company name;
- Occupier registered company address; and
- DWER File Record Number.

3. Consultation

The Mindarie Regional Council was provided with the draft Amendment Report on 22 December 2021 but no comments were received.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended licence will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.

4.1 Summary of amendments
