1. Decision summary

The Delegated Officer has determined to transfer Licence L8402/2009/2 to DC Mines Pty Ltd.

The decision document for the existing licence will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In transferring the licence, the Department of Water and Environmental Regulation (DWER) has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents

2.2 Transfer summary

The licence L8402/2009/2 is currently held by Minjar Gold Pty Ltd (Licence Holder) for the Golden Dragon Mine (the Premises), located at Mining Lease M59/406, Yalgoo WA 6635.

The premises prescribed activities are categories 5 and 64, and the site is currently in care and maintenance. The assessed design/production capacity under Schedule 1 of the *Environmental Protection Regulations* 1987 (EP Regulations) are defined in Licence L8402/2009/2.

The amendment is limited to the transfer of Licence L8402/2009/2 from Minjar Gold Pty Ltd to DC Mines Pty Ltd.

3. Assessment

The transfer assessment includes:

- A review of legal occupancy to determine if a transfer may occur;
- A review of compliance with current licenses held by the company or directors; and
- An administrative review of the licence, including clerical and administrative details (see Table 1).

3.1 Legal Occupancy

DC Mines Pty Ltd is the current leaseholder of Mining Lease M59/406-I where the premises is located.

3.2 Legal Entity Status

DC Mines Pty Ltd is a registered and valid current entry on the Australian and Investment Commission register (ACN: 653 399 627) and is, therefore, a legal entity.

There are no significant compliance matters relating to DC Mines Pty Ltd or its directors, that would prevent the issue of this transfer.

4. Conclusion

Based on the assessment in this Transfer Report, DWER has determined that DC Mines Pty Ltd is a legal entity and a fit and competent operator. DWER will, therefore, transfer licence L8402/2009/2 to DC Mines Pty Ltd.

4.1 Summary of amendments
