## Amendment Notice

This amendment is made pursuant to section 59 of the *Environmental Protection Act 1986* (EP Act) to amend the Licence issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

### Amendment description

Amendment Notice 2 granted on 24 April 2018 provided a period of time within which the Licence Holder could commission and operate the modular asphalt plant. Due to delays in the delivery of the new asphalt plant, the Licence Holder has requested later dates to operate equipment.

The requested change is of an administrative nature – there are no changes to the emissions of wastes or risks to the environment.
