Amendment Notice

This notice is issued under section 59 of the *Environmental Protection Act* 1986 (EP Act) to amend the licence issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

Amendment Description

Licence L6561/1995/11 was amended on 4 February 2016 to include the composting activities on the same licence as the asphalt manufacturing. As part of the licence amendment, an improvement condition, condition 4.1.1, was included to require the Licence Holder to submit a Dust and Odour Management Plan. The Licence Holder submitted the Dust and Odour Management Plan on 24 May 2016. The Delegated Officer reviewed the plan and determined that further information was required. The Licence Holder submitted a revised Dust and Odour Management Plan on 14 June 2016.

Decision

The Delegated Officer has reviewed the revised Dust and Odour Management Plan and determined that the revised plan meets the requirements of condition 4.1.1. As the requirements of condition 4.1.1 have been met, the condition is no longer required and is therefore removed from the licence.
