Amendment Notice

This notice is issued under section 59 of the *Environmental Protection Act* 1986 (EP Act) to amend the licence issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

Amendment Description

On 28 September 2016, Amendment Notice 1 was issued to the Southern Ports Authority (SPA) allowing for the use of mobile equipment for the loading of mineral sands on a trial basis at Berth 5 of the Port of Bunbury until the end of the 2016 calendar year. The SPA hold Licence L6744/1996/12 issued under Part V of the EP Act for the Port of Bunbury (Premises).

DER is also currently undertaking a full risk-based review of the Premises in accordance with its regulatory framework. This risk-based review and assessment is scheduled to be completed in early 2017 and will include all prescribed premises activities.

Following the issuing of the Amendment Notice, SPA sent a letter on 30 November 2016 requesting an extension for the use of mobile equipment for the loading of mineral sands until 30 June 2017 or until such time as the separate risk-based review is completed.

Decision

The Delegated Officer has determined that an amendment to permit the time extension for the use of mobile ship loading equipment for the loading of mineral sands to 30 June 2017 is appropriate.

The Delegated Officer considers that the risks have not changed since the Amendment Notice 1 was issued and that given a full risk-based review of the Premises is currently underway and scheduled for completion in early 2017, a full risk assessment is not required for this amendment. In addition the Delegated Officer notes that there is no record of any complaints being lodged with the DER for the premises and no non-compliances reported by the Licence Holder during the operation of the mobile equipment.

No changes in addition to the extension requested by the Licence Holder have been made.
