Amendment Notice

This amendment is made pursuant to section 59 of the *Environmental Protection Act 1986* (EP Act) to amend the Licence issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

As the Department of Water and Environmental Regulation (DWER) has not yet completed the development of guidelines on the full reassessment of renewed licenses, the Delegated Officer intends to extend the license expiry date for the premises. A full reassessment of the premises license and operations will be considered on a risk-basis within the context of DWER's License Review Programme.

This notice is limited only to an amendment for the licence duration. No changes to the aspects of the original licence relating to Category 61 have been requested by the Licence Holder.

The following guidance statements have informed the decision made on this amendment.

Amendment description

The Margaret River Septage Treatment Plant accepts sewage and grease trap waste from the Shire of Augusta- Margaret River. This amendment notice is a result of a DWER initiated amendment to extend the licence duration by a further 5 years from 26 July 2019 to 26 July 2024.
