Amendment Notice

This amendment is made pursuant to section 59 of the *Environmental Protection Act 1986* (EP Act) to amend the Licence issued under the EP Act for a Prescribed Premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

This notice of amendment is limited to an extension of the reporting dates for both the Annual Environmental Report (AER) and the Annual Audit Compliance Report (AACR). No changes relating to the prescribed premises Category 55 for this licence have been requested by the Licence Holder.

Amendment description

The Shire of Plantagenet (the Licence Holder) holds Licence L7407/1998/9 granted on 23 February 2012 (Existing Licence) for a cattle saleyards facility at Lot 3 on Plan 19319 Albany Highway, Mount Barker (the Premises). The Licence Holder lodged an application to DWER to amend the Existing Licence on 10 December 2018.

The Licence Holder requested that the due date for submission of the AER be extended by one calendar month (from current due date of 31 January) on the basis of the practical timing pressures for conducting final end of year water sampling and testing due in the month of December, obtaining these test results and their subsequent integration into annual reporting, noting that reports are due immediately following the Christmas / New Year holiday period.

In addition to the Licence Holder's requested change, the Delegated Officer considers that the associated Annual Audit Compliance Reporting date should also be extended by the same timeframe to provide consistency with annual reporting requirements.

Decision

This Amendment Notice is the result of an administrative amendment and it does not require any risk assessment. Minor administrative amendments to Licence definitions have been included.

The Delegated Officer has considered DWER's *Guidance Statement: Regulatory Principles* and *Guidance Statement: Decision Making* in granting this amendment.

The Licence Holder was provided with the draft Amendment Notice on 17 December 2018. The Licence Holder notified the Delegated Officer in writing on 17/12/2018 that it had no objection to the proposed amendment and requested that the 21 day consultation period be waived.

REPORTING CONDITIONS

ANNUAL ENVIRONMENTAL REPORT

- 19. The licenseeLicence Holder shall provide the DirectorCEO, by 31 January 1 March each year, an Annual Environmental Report containing data collected for 1 January in the previous year to 31 December of that year. The report shall contain, but not necessarily be limited to:
 - (a) the total number of animals held on site on a monthly basis;
 - (b) monitoring data or other collected data required by any condition of this licence (data should be provided in tabular and in graphical format);
 - (c) an assessment of the data collected against all limits set in this licence;
 - (d) an explanation of the data in comparison with past data collected over the previous three years, and known applicable guidelines and standards;

- (e) a discussion of the operation of the project, compliance with conditions, and environmental performance to date;
- (f) any issues raised from inspections or incident responses during the reporting period together with details as to how these have been addressed or, if the required work has yet to be completed, how and when they will be completed; and
- (g) any changes to site boundaries, location of groundwater monitoring bores, surface drainage channels and on-site or off-site impacts or pollution.
- 3. Condition 20 of the Licence is amended by the deletion of the text shown in strikethrough below and the insertion of the red text shown in underline below:

ANNUAL AUDIT COMPLIANCE REPORT

- 20. The licenseeLicence Holder shall by 31 January 1 March in each year, provide to the Director CEO an Annual Audit Compliance Report in the form in Attachment 2 to this licence, signed and certified in the manner required by Section C of the form, indicating the extent to which the licenseeLicence Holder has complied with the conditions of this Licencelicence, and any previous licence issued under Part V of the Act for the premises, during the period beginning 1 January the previous year and ending on 31 December in that year.
