Amendment Description

An application for a licence amendment was received from the Licence Holder on 27 February 2017, to amend reporting condition 4.2.1 dates from 1st August to 1st September to allow more time to compile annual reports.

Decision

The Delegated Officer considers that the following amendment to change the annual reporting date for condition 4.2.1 is administrative and does not increase the risk rating of the premises. Other administrative amendments relating to this condition and the new Annual Audit Compliance Report (ACCR) Form have been included in the licence amendment.

- 3. Condition 4.2.1 of the licence is amended by the by the deletion of the text shown in strikethrough below and the insertion of the red text shown in underline below:

Condition 4.2.1: The Licensee shall submit to the CEO an Annual Environmental Report by <u>1 August</u> <u>1 September</u> each year. The report shall contain the information listed in Table 4.2.1 in the format or form specified in that table.
