Amendment Notice

This Notice is issued under section 59 of the *Environmental Protection Act* 1986 (EP Act) to amend the licence issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

Amendment Description

The Department of Corrective Services (the Licence Holder) was granted works approval W5693/20143/1 on 7 August 2014 to install a new wastewater treatment plant at the premises. DER subsequently granted an amended licence on 9 June 2016 to reflect the operational aspect of works authorised under W5693/2014/1 following the submission of the associated compliance document and the related licence amendment application.

As part of the licence amendment, the Licence Holder was required to provide a Management Plan outlining how emissions to land will be decreased by 30 June 2018. The Management Plan was required to be submitted 1 October 2016. The Licence Holder was not able to complete the Management Plan by the specified completion date.

On 27 September 2016, the Licence Holder requested an amendment to extend the submission date of the Management Plan to 1 December 2016. No other changes were proposed.

Decision

The Delegated Officer has determined that an administrative amendment is to be made to extend the submission date for IR1 in Table 4.1.1 of conditions 4.1.1 and 4.1.2.

A detailed risk-assessment is not required as the proposed amendment is administrative in nature and does not impact of the emissions and discharges from the premises. There are no other changes to the licence.
