Amendment

Notice of an Amendment

This amendment is made pursuant to section 59 of the *Environmental Protection Act 1986* (EP Act) to amend Licence L8404/2009/2 issued to Bradken Resources under the EP Act for its premises in Wundowie. This notice of an amendment is given under section 59B(10) of the EP Act and is provided in the form of a revised Licence, attached to this report.

Amendment description

The Licence Holder lodged an application to amend its licence on 20 December 2018 after installation of a new baghouse, the subject of Works Approval W6130/2018/1. New Condition 2.2.1 through to Condition 2.2.5 have been added to the licence to give effect to the application. The documents that form the application are set out in Appendix 1 as well as Departmental guidance that has informed assessment of the application.

While giving effect to this application, the Delegated Officer has also attended to the following administrative matters in the Licence:

- incorporation of the 2016 Notice of Amendment;
- correcting the premises address;
- noting that the Department of Water and Environmental Regulation is the current Department administering the *Environmental Protection Act 1986*;
- updating the Introduction section;
- correcting and updating the Instrument Log table;
- correcting Condition 1.1 by updating the definition used in the Licence;
- updating the headers and footers;
- updating maps of the premises; and
- removing the out of date Annual Audit Compliance Reporting form and making reference to the form available on the Department's website.

Recent regulatory approvals

Decision

The Delegated Officer has granted the application to amendment Licence in the form of a revised Licence as attached.

Basis for the decision

The Licence Holder provided a commissioning report for the baghouse filter, by email of 20 December 2018. The commissioning report confirms that the baghouse filter had been installed as per Works Approval W6130/2018/1, although without the broken bag detection system as was required in the conditions of that Works Approval. The Licence Holder provided a commitment in an email from 4 April 2019 that this would be installed prior to 10 May 2019.

The department has not received any complaints regarding Bradken since the installation of the new baghouse filter.

The licence has not been updated since 5 September 2013 and typographical and grammatical errors should be corrected.

Licence Holder's comments

The Licence Holder was provided with the draft Notice of an Amendment 19 June 2019 and also a revised Licence in the form of a 'tracked changes' version that outlined all of the changes made to the licence. A 'clean' version of the draft revised licence without 'tracked changes has also been provided to assist the Licence Holder. The Licence Holder responded per email of 5 July 2019 that there were no comments on the draft revised licence.
