Amendment Notice

This notice is issued under section 59 of the *Environmental Protection Act* 1986 (EP Act) to amend the licence issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

Amendment Description

The Licence Holder operates the Byford Hard Rock Quarry located near Mundijong, approximately 45 km south of Perth. The quarry supplies hard rock products for the expanding metropolitan area.

On 17 September 2015 a works approval (W5841/2015/1) was issued to Hanson Construction Material Pty Ltd for the construction of a concrete batching plant (the Plant). The Plant will provide premixed concrete for the domestic, commercial and civil construction industries and is subject to the *Environmental Protection (Concrete Batching and Cement Product Manufacturing) Regulations 1998*.

Correspondence dated 11 October 2016 was received by DER advising of the completion of works for the Plant. Review of the correspondence determined that conditions 2.1.1 and 2.1.2 of works approval W5841/2015/1 had been met. On 4 November 2016 the Licence Holder submitted an application to include the Plant onto their existing licence L8432/2010/3 as a Category 77- Concrete batching or cement products manufacturing prescribed premises.

Decision

This amendment notice is issued to include the Plant onto the licence. The proposed changes do not alter the risk of the premises or the type and quantities of waste emitted.
