Amendment Notice

This amendment is made pursuant to section 59 of the *Environmental Protection Act* 1986 (EP Act) to amend the licence issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

This notice is limited only to an amendment for the number of cattle held in the feedlot at Paradise Beef Feedlot (the premises).

The following DER Guidance Statements have informed the decision made on this amendment:

- Guidance Statement: Decision Making (February 2017); and
- Guidance Statement: Risk Assessments (February 2017).

Amendment Description

The Licence Holder lodged an application for a licence amendment on 15 May 2017 following an expansion to the premises, with the construction of six feedlot pens and evaporation pond. The works were constructed under Works Approval W5125 and complete stage one of the expansion.

The application relates to increasing the maximum number of cattle permitted to be held on the premises (2,000 cattle).

The amendment increases the number of cattle permitted to be held on the premises up to 2,000 cattle and updates maps and drawings of the infrastructure on the premises.

Decision

The Delegated Officer considers that the licence amendment should be granted. The provision of the licence amendment follows on from the completion of stage one works under Works Approval W5125.

Reasons for Decision

The principal reason for granting the amendment is that the amendment follows on from completion of works that were subject to a works approval. In making the decision to grant the licence amendment, the Delegated Officer considered the assessment associated with Works Approval W5125, the compliance document for stage one works and the premises licence compliance and complaint history. The risks to the environment and public health will not increase as a result of granting the amendment.

Condition	Summary of Licence Holder comment	DER response
1.	Rewording the text of condition one by stating the number of cattle held on the premises instead of the feedlot, limits the Licence Holder's ability to have cattle grazing in paddocks within the premises boundary (outside the feedlot) in addition to maximum 2,000 cattle held in the feedlot.	Revert the wording of the condition back to its original form to read "held in the cattle feedlot". This will allow the Licence Holder to continue to have the option of grazing a small number of cattle in the paddocks within the premises boundary.
