Amendment Notice

This amendment is made pursuant to section 59 of the *Environmental Protection Act 1986* (EP Act) to amend the Licence issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

This notice is limited only to an amendment for Category 12.

The following guidance statements have informed the decision made on this amendment:

Amendment description

On 19 December 2016 the Chief Executive Office issued a revised licence for the Redgate Lime Quarry situated on Redgate Road, Redgate.

The Minister for Environment received an appeal (Appeal Number: 003 of 2017) against the conditions of the licence. The appeal related to the adequacy of dust management. The Minister allowed the appeal to the extent that condition 3.1.1 of the licence be amended to include a reference to the relevant Australian Standard for the siting of monitoring equipment. This amendment gives effect to the Minister's decision.

Decision

The Delegated Officer was not required to undertake a decision-making process at this time. The changes undertaken in this amendment reflect the Minister's decision on Appeal Number: 003 of 2017.

Licence Holder's comments

As required by section 59B of the *Environmental Protection Act 1986*, the Licence Holder was provided with the draft Amendment Notice on 13 December 2017. No comments were received.

Amendment

- 1. Condition 3.1.1 of the Licence is amended by the insertion of the red text shown in underline below:
- 3.1.1 The Licensee shall carry out dust monitoring in accordance with the requirements set out in Table 3.1.1 below, with monitoring equipment sited in accordance with Australian Standard AS/NZS3580.1.1:2007 Guide to siting air monitoring equipment.
