Amendment Notice

This amendment is made pursuant to section 59 of the *Environmental Protection Act 1986* (EP Act) to amend the Licence issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

This notice is limited only to an amendment for to the Premises name. No changes to the aspects of the Existing Licence relating to Category 62 operations have been requested by the Licence Holder.

Amendment description

The City of Perth (the Licence Holder) operates a 5,000 tonnes per annual period solid waste depot at 199 Thelma Street, Como.

This Amendment Notice is the result of a Licence Holder initiated amendment. On 24 February 2017 the Licence Holder submitted an amendment application to request that the name of the Premises be amended from 'Collier Park Waste Transfer Station' to 'City of South Perth – Recycling Centre'. No other changes are proposed to existing Licence L8559/2011/1.
