

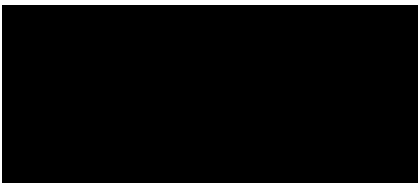

Amendment Notice

This amendment is made pursuant to section 59 of the *Environmental Protection Act 1986* (EP Act) to amend the Licence issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

The following guidance statement has informed the decision made on this amendment:

- *Guidance Statement: Licence Duration* (August 2016)

Amendment description

Ravensdown Fertiliser Co-operative Limited Pty Ltd was granted a Licence on 20 December 2012 under Part V of the EP Act for the operation of a category 33 chemical blending or mixing operation on Edward Street in Meru (the Premises). The Licence was transferred from Ravensdown Fertiliser Co-operative Limited to Macrofertil Australia Pty Ltd (Licence Holder) on 13 March 2014.

This Amendment Notice is the result of a DWER initiated amendment and relates to the extension of the licence expiry date from 23 December 2017 to 23 December 2027.

Decision

Section 63 of the EP Act prescribes that a licence shall continue in force for such period as is specified in the licence. Licence L8681/2012/1 is due to expire on 23 December 2017.

In determining to amend the expiry date of the licence, the Delegated Officer has considered that the risks posed by emissions from the premises during operation have not changed since the licence was granted. The City of Greater Geraldton have advised the DWER that there are no time limitations for the approved development which is the premises.

No other changes have been made to the licence.

Licence Holder's comments

The Licence Holder was provided with the draft Amendment Notice on 8 November 2017 and waived the remainder of the statutory consultation period in electronic mail to the DWER dated 13 November 2017.

Amendment

1. The expiry date of the Licence has been extended from 23 December 2017 to 23 December 2027.
