Amendment Notice

This amendment is made pursuant to section 59 of the *Environmental Protection Act 1986* (EP Act) to amend the Licence issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

This notice is limited only to an amendment for Category 5.

The following guidance statements have informed the decision made on this amendment:

Amendment description

Urban Resources Pty Ltd (the Licensee) has applied for an amendment to the Licence to reflect the additional operations of the wet beneficiating plant that has now been commissioned as outlined in the related works approval W5694/2014/1. The changes to the licence will be limited to an increase in production to 270 000 tonnes/year, 150 000 dry screening tonnes and 120 000 wet beneficiating tonnes.

Decision

The construction of the wet beneficiating plant has been completed as proposed in Works Approval W5694/2014/1. No deviation from the original design has been reported and the risk assessment undertaken in the Works Approval Decision Document applies to the operations for the wet beneficiating plant.

Licence Holder controls for the addition of the wet beneficiating plant are conditioned on the licence to ensure that record keeping of total tonnes processed is undertaken and reported in the Annual Environmental Report.

Conditions currently on the Licence capture operational emissions relating to wet screening. Conditions have been updated in the licence to reflect DWER's current Guidance Statements.

Licence Holder's comments

The Licence Holder was provided with the draft Amendment Notice on 30 November 2017. The Licence Holder advised on 5 December 2017 that they had no comments.
