1. Development shall be in accordance with the attached approved plan(s) dated **13 May 2024** and subject to any modifications required as a consequence of any condition(s) of this approval. The endorsed plans shall not be modified or altered without the prior written approval of the local government.

Advice:

a. In considering the above application the City notes that the existing development on the lot does not comply with the relevant planning approval. Please find attached a copy of that previous approval (Reference TP11/376) – see approved plan and in particular conditions 1-3, condition 6 and 7. It is noted that you were not the owner and/or applicant at the time. However as the owner of the property the responsibility for compliance with relevant planning (and building) approval/s is now your responsibility.

Notes:

- i. If the development, the subject of this approval, is not substantially commenced within a period of two years after the date of determination, the approval shall lapse and be of no further effect.
- ii. Where an approval has so lapsed, no development shall be carried out without the further approval of the local government having first been sought and obtained.
- iii. If an applicant is aggrieved by this determination there is a right (pursuant to the *Planning and Development Act 2005*) to have the decision reviewed by the State Administrative Tribunal. Such application must be lodged within 28 days from the date of determination.





iv. Any additions to or change of use of any part of the building or land (not the subject of this approval) requires further application and development approval.
