Part 4.8 Maximum production or design capacity each category applied for (based on infrastructure operating 24 hours a day, 7 days a week):

Category 57: Used Tyres Storage (General) – 250 tyres Per Annual Period.

Category 61: Liquid Hazardous Waste- 1,000 tonnes Per Annual Period.

Category 62: Solid Hazardous Waste 2,000 tonnes Per Annual Period.

Category 64: Class II or II Putrescible Waste & Contaminated solid waste meeting waste acceptance criteria specified for Class II landfills- 250,000 tonnes Per Annual Period.



Stage 4 landfill capping - page 4 requirement (g) amendment.

Increase immediate cover of the waste material that is exposed during installation from 500 mm to 1,000 mm/1 meter of suitable soil cover.
