2. Amendment description

Hanson Construction Materials Pty Ltd (Licence Holder) applied for an amendment to Licence L4593/1983/13 on 15 November 2019. The Licence Holder requests to have Lot 3 removed from the Licence as they no longer operate on that lot or have any prescribed activity there.

3. Consideration

The Licence is issued to the Licence Holder for category 12. This category is for premises (other than premises within category 5 or 8) on which material extracted from the ground is screened, washed, crushed, ground, milled, sized or separated. The Licence Holder has crushing and screening equipment located on Lot 27.

Removing Lot 3 from the Premises, does not increase or significantly change the environmental risk profile of the Premises as removal increases the separation distance between potential emissions and discharges arising from the premises activities and sensitive receptors.

The Delegated Officer has therefore decided that no further risk assessment is required and that the amendment can be granted.

In conjunction with the Licence Holder's amendment application, the CEO has initiated an administrative amendment to the type and style of licence to reflect the new Department details and licence format. Conditions of the existing licence have been transferred, but not reassessed, to the amended licence. Where appropriate some conditions which did not contain specific requirements have been removed, and some conditions have been modified to reflect current condition wording. The obligations of the Licence Holder have not changed in making these changes

The licence amendments are summarised in Table 2.

3.1 Summary of amendments

Table 2 provides a summary of the proposed amendments and will act as record of implemented changes. All proposed changes have been incorporated into the Amended Licence as part of the amendment process. Condition numbering has also been adjusted to reflect the removal of conditions.
