# 1. Decision summary

The Delegated Officer has determined to make amendments to Licence L8466/2021/3. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that the activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the recently issued renewed licence will remain on the department's website for future reference and will act as a record of the department's decision making.

### 2. Scope of assessment

#### 2.1 Regulatory framework

In amending the licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <u>https://dwer.wa.gov.au/regulatory-documents</u>.

#### 2.2 Amendment summary

Licence L8466/2021/3 is held by Water Corporation (Licence Holder) for the Southern Seawater Desalination Plant (the Premises), located at Taranto Road, Binningup, approximately 30km north of Bunbury.

The Premises relates to the category 54A: Water desalination plant and the assessed design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Licence L8466/2010/3 issued on 17 December 2021.

On 6 January 2022, the department initiated an amendment to Licence L8466/2021/3 The amendment is limited to correcting typographical errors and minor updating of table formatting.

## 3. Consultation

The Licence Holder was provided with the draft revised Licence and Amendment Report on 07 January 2022. On 10 January 2022 the Licence Holder waived the comment period, confirming acceptance of administrative amendments as drafted and noting further minor corrections to condition cross-referencing in Condition 18, Table 6.

## 4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended licence will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
