1. Decision summary

The Delegated Officer has determined to make amendments to Licence L8966/2016/1. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the existing Licence will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the Licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <https://dwer.wa.gov.au/regulatory-documents>.

2.2 Application summary

Licence L8966/2016/1 is held by Appala Holdings Pty Ltd T/A Wastetrans WA (Licence Holder) for the Postans Glass Processing & Waste Sorting Facility (the Premises), located at 119 McLaughlin Road, Postans WA.

The Premises relates to the Category 61A and the assessed production/design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Licence L8966/2016/1.

On 30 November 2021, the Licence Holder submitted an application to the department to amend Licence L8966/2016/1 under section 59B of the *Environmental Protection Act 1986* (EP Act). The amendment is limited only to the following:

- updating the Licence Holders trading name;
- Inclusion of reference to Landfill Definitions for Clean fill in condition 1;
- renumbering of conditions;
- rectification of typographical errors;
- updating the Licence to the department's current format;
- updating references to guidelines;
- updating of premises map to include GPS coordinates of the premises boundary;
- deletion of redundant conditions; and
- inclusion of a definitions table (to replace previous format structure of definitions).

3. Consultation

The Licence Holder was provided with the draft Amendment Report on 11 February 2022. On 11 February 2022 the Licence Holder waived the comment period.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined

that an amended Licence will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
