1. Decision summary

The Delegated Officer has determined to make amendments to works approval W6576/2021/1. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the Existing works approval will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the works approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

2.2 Amendment summary

Works approval W6576/2021/1 is held by Habrok (Rydges) Pty Ltd (Works Approval Holder) for the Matsu Iron Ore Project (the Premises), located at Mining tenements G80/21 and M80/625 and Part of Mining tenements L80/82 and L80/84.

The Premises relates to the categories and the assessed design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Works Approval W6576/2021/1.

On 18 October 2021, the department initiated an amendment to works approval W6576/2021/1 as it was identified that the instrument was issued with an error within condition 6, table 2. The Existing works approval was issued on 20 August 2021. The error relates to the volumes of inert waste type 1 and inert waste type 2 approved for acceptance at the premises Class 1 inert landfill (Landfill 2).

There has been no change to the total volume of waste approved for disposal under Category 63: Class I inert landfill site and therefore this amendment does not alter the risk profile of the premises.

3. Consultation

On 26 October 2021 the Works Approval Holder waived the comment period.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended works approval will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.

4.1 Summary of amendments

Table 1 below provides a summary of the proposed amendments and will act as a record of implemented changes. All proposed changes have been incorporated into the Revised works approval as part of the amendment process.
