## 1. Decision summary

The Delegated Officer has determined to make amendments to Licence L4467/1972/14. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the existing licence will remain on the department's website for future reference and will act as a record of the department's decision making.

## 2. Scope of assessment

#### 2.1 Regulatory framework

#### 2.2 Application summary

Licence L4467/1972/14 is held by Chevron Australia Pty Ltd (Licence Holder) for the Barrow Island Oil and Gas Facility (the Premises), located at Barrow Island (Crown Reserve 11648).

The Premises relates to the categories and the assessed production capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Licence L4467/1972/14.

On 22 August 2024 the Licence Holder submitted an application to the department to amend Licence L4467/1972/14 under section 59B of the *Environmental Protection Act 1986* (EP Act). The amendment is limited only to changing the premises boundary.

Barrow Island includes two licenced premises held by the licence holder, the Barrow Island Oil and Gas Facility (L4467/1972/14) and the Gorgon LNG Project (L9102/2017/1). The purpose of this amendment is to realign the boundary between the two prescribed premises.

#### 3. Consultation

The Licence Holder was provided with the draft Amendment Report on 13 March 2025. The Licence Holder responded on 13 March 2025 and waived the comment period.

#### 4. Decision

The Delegated Officer has determined that the proposal to amend the boundary of the prescribed premises does not change the risk profile of the premises. The boundary amendment removes areas from the Barrow Island Oil and Gas Facility premises which are now under the operational control of the Gorgon LNG Project. The Delegated Officer additionally included a heading for table 2 to correct a clerical error of a missing heading.

#### 5. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended licence will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
