1. Amendment description

This amendment is made pursuant to section 59 of the *Environmental Protection Act 1986* (EP Act) to amend an existing licence issued under the EP Act for a prescribed premises as set out below. This amendment report is hereby given under section 59B(9) of the EP Act.

This amendment has been initiated by the Chief Executive Officer of the Department of Water and Environmental Regulation (DWER). The amendments are administrative in nature and do not change the risk profile of the premises, as long as activities, emissions, and receptors remain the same as in existing approvals.

In amending the licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <u>https://dwer.wa.gov.au/regulatory-documents</u>.

1.1 Background

Cutting Cart holds licence L5177/1989/13 for operating Dardanup Butchering Co (DBC) Abattoir, a multi-species abattoir with a design capacity of less than 30,000 tonnes per year (liveweight). On 28 May 2024, the licence holder lodged an appeal to several conditions of the licence. Following discussions between the licence holder and the Delegated Officer, the licence holder withdraws its appeal, and the Delegated officer agreed to initiate this licence amendment.

2. Consultation

The licence holder was provided with the draft licence and amendment report on 15 April 2025.

On 1 May 2025 the licence holder accepted the amendments without comment.

3. Conclusion

Based on this assessment, it has been determined to amend the existing licence, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements

3.1 Summary of amendments

Table 1 below provides a summary of the proposed amendments and will act as a record of implemented changes. All proposed changes have been incorporated into the Revised licence as part of the amendment process.
