1. Decision summary

The Delegated Officer has determined to make amendments to Licence L5320/1988/15 (Licence). The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the existing licence will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

2.2 Amendment summary

Licence L5320 is held by Tronox Management Pty Ltd (Licence Holder) for the Tronox Kwinana Pigment Plant (the Premises), located at Lot 22 Mason Road, Kwinana Beach.

The Premises relates to the categories and the assessed production capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in the existing Licence.

On 14 October 2025, the department initiated an amendment to the Licence. The amendment is limited to the addition of assessed design capacity figures provided by the applicant into the prescribed premise category description table. No changes to the prescribed activities of the premise are considered within this amendment as such there are no changes to the risk profile of prescribed activities.

3. Consultation

On 22 October 2025, after provision of the draft amendment, the Licence Holder waived the comment period.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended licence will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
