1. Decision summary

The delegated officer has determined to make amendments to licence L5366/1972/14. The amendments are administrative in nature as they do not alter the risk profile of emissions from the premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the existing licence will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <https://dwer.wa.gov.au/regulatory-documents>.

2.2 Application summary

Licence L5366/1972/14 is held by Electricity Generation and Retail Corporation who trade as Synergy (licence holder) for the Kwinana Power Station (the Premises), located at 22 Leath Road, Naval Base.

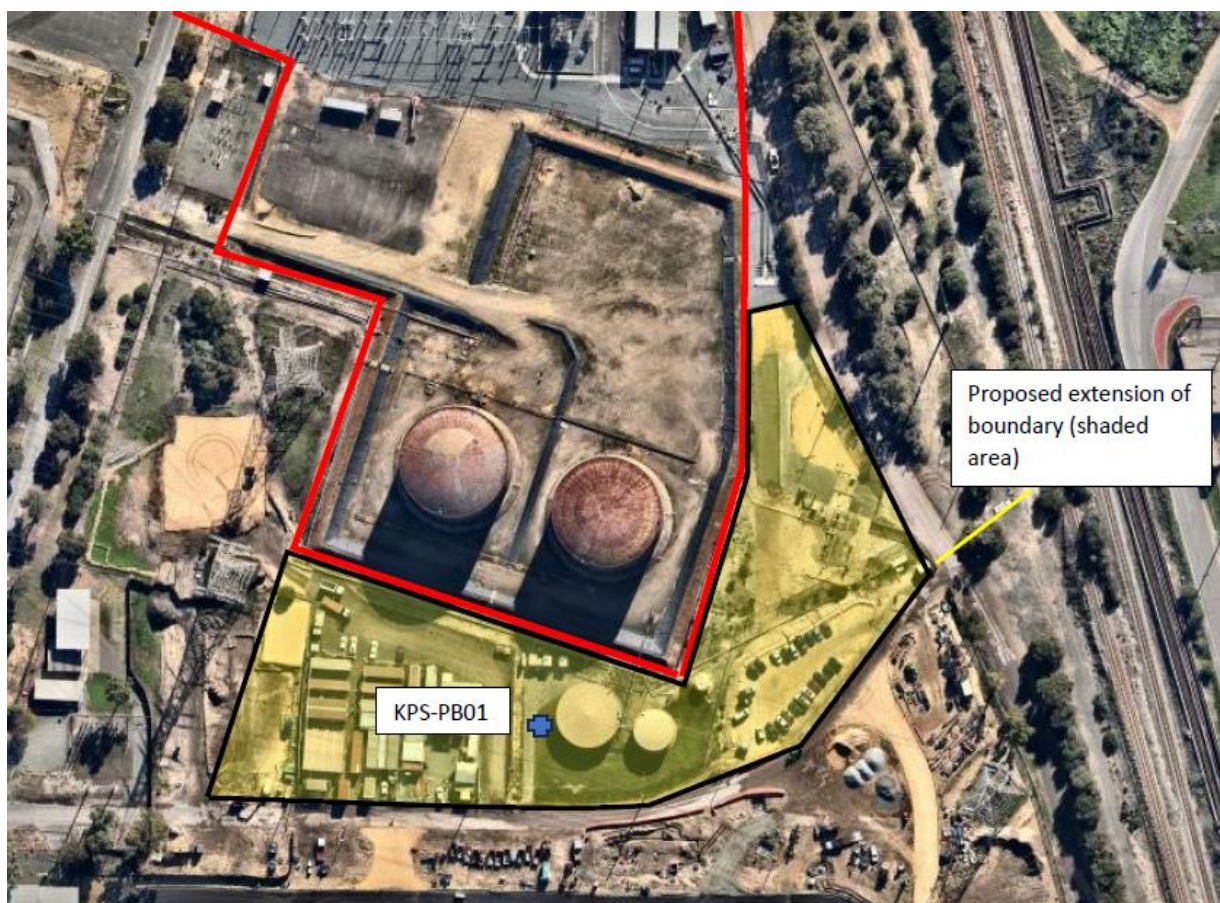


Figure 1: Boundary extension for inclusion of production bore

On 3 April 2025, the licence holder submitted an application to amend L5366/1972/14 under section 59B of the *Environmental Protection Act 1986* (EP Act). The amendment is limited to a minor change of the premises boundary, to include a new production bore (KPS-PB01) that has been recently installed to replace other decommissioned bores. Figure 1 shows the area to be included in the prescribed premises.

Water abstracted from the new bore will be delivered to existing storage tanks and directed to the existing reverse osmosis plant, for treatment and use as process water, under existing licence conditions.

3. Decision

The delegated officer has determined the requested change to the premises boundary does not significantly alter the assessed risk profile of the premises and therefore has redescribed the boundary of the premises to which the licence applies (section 59(1)(c) of the EP Act).

3.1 Licence holder comment

The licence holder was provided with a draft revised licence and this report on 27 June 2025, who waived the comment period with no additional comment.

4. Conclusion

The delegated officer has determined that an amended licence will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
