Amendment description

This amendment is made pursuant to section 59 of the *Environmental Protection Act 1986* (EP Act) to amend the existing licence issued in respect of the prescribed premises as set out below. This notice of amendment is hereby given under section 59B(9) of the EP Act.

This amendment is limited to extending the duration of the licence, updating the format of the front page, updating references to the department, and removing the AACR form template. No changes have been made to existing conditions or licence holder obligations.

In completing the assessment documented in this report, the department has considered and given due regard to its regulatory framework and relevant policy documents which are available at www.wa.gov.au/service/building-utilities-and-essential-services/integrated-essential-services/dwer-regulatory-documents.

Background

Licence L5982/1994/11 is held by Jetstar Enterprises Pty Ltd (licence holder) for the Permapole – Mundijong (premises) located at 394 Robertson Rd, Cardup within the Shire of Serpentine-Jarrahdale.

The licence relates to the operation of a timber preservation facility. Raw pine logs are received on the premises where they are kept damp via irrigation prior to debarking. The debarked logs are treated with copper chrome arsenate and then cured for a minimum of 7 days (longer in winter). Cured timber is then stored onsite with potentially contaminated stormwater directed to an onsite lined containment pond.

On 23 August 2023, the licence holder submitted a licence renewal application under Division 3, Part V of the EP Act for the premises to continue operating under licence L5982/1994/11. The licence is due to expire on 28 September 2023. Due to time constraints, the department has been unable to complete the review and risk assessment of emissions and discharges from the premises and has therefore determined to undertake a licence amendment to extend the licence expiry date by 12 months to allow the review and a renewed licence to be granted.

Consultation

The licence holder was provided with the draft amended licence on 31 August 2023. The licence holder did not provide a response within the requested timeframe.

Decision

Based on the assessment outlined in this amendment report, the delegated officer has amended licence L5982/1994/11 to extend the expiry date by 12 months. This, and other administrative changes, are summarised below. No changes have been made to existing conditions or licence holder obligations.

The decision report for the existing licence will remain on the department's website for future reference and will act as a record of the department's decision making.
