1. Decision summary

The Delegated Officer has determined to make amendments to Licence L6306/1989/11. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the Existing licence will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

2.2 Application summary

Licence L6306/1989/11 is held by Wesfarmers LPG Pty Ltd (Licence Holder) for the Wesfarmers LPG (the Premises), located at Part of Lot 102 on Plan 73740, Kwinana Beach, Western Australia.

The Premises relates to the category and the assessed production/design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Licence L6306/1989/11.

On 10 December 2024, the Licence Holder submitted an application to the department to amend Licence L6306/1989/11 under section 59B of the *Environmental Protection Act 1986* (EP Act).

The amendment is limited only to:

- Changing the premises boundary to remove a section of the premises that relates to Category 81 activities; and
- Removing Category 81 from the licence as the Licence Holder no longer undertakes these activities at the premises.

The Licence Holder advised that the portion of the business undertaking Category 81 activities was sold to a third party (Supagas Pty Ltd) in December 2024. Supagas Pty Ltd has since applied for a registration under the EP Regulations to continue these activities (R2885/2025/1).

3. Consultation

The Licence Holder was provided with the draft Revised Licence and draft Amendment Report on 27 March 2025. The Licence Holder responded on 2 May 2025, providing updated premises boundary information and requesting that an error in the definition for "annual period" is corrected

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended licence will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.

The Licence Holder also proposed a change to the premises boundary to exclude a section in the north-east corner (points J to L), which is not under the operational control of Wesfarmers LPG. Updates to the premises boundary specified by the Licence have been made as requested.

4.1 Summary of amendments

Table 1 below provides a summary of the proposed amendments and will act as a record of implemented changes. All proposed changes have been incorporated into the Revised licence as part of the amendment process.
