1. Decision summary

Licence L6543/1991/12 is held by the Water Corporation (Licence Holder) for the Kwinana Water Resource Recovery Facility (the Premises), located at 119 and 143 McLaughlan Road, Postans WA 6167.

The Delegated Officer has determined to make amendments to Licence L6543/1991/12. The amendments outlined within this amendment report do not alter the risk profile of the Premises. As a result of this assessment, Revised Licence L6543/1991/12 has been granted.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The Revised Licence issued as a result of this amendment consolidates and supersedes the existing Licence previously granted in relation to the Premises. The Revised Licence has been granted in a new format with existing conditions being transferred, but not reassessed, to the new format.

The decision report for the Existing Licence will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <https://dwer.wa.gov.au/regulatory-documents>.

2.2 Application summary

On 13 March 2023, the Licence Holder submitted an application to the department to amend Licence L6543/1991/12 under section 59 and 59B of the *Environmental Protection Act 1986* (EP Act). The amendment is limited only to altering the due date for the environmental report and annual audit compliance report, to be 1 October annually. In amending the licence, the CEO has:

- updated the format and appearance of the Licence; and
- corrected clerical mistakes and unintentional errors.

No changes to the aspects of the Existing Licence relating to Category 54 have been requested by the Licence Holder. Table 1 below outlines the current approved production/design capacity for the Premises.

Table 1: Approved production/design capacity

Category 54 Sewage facility: premises — (a) on which sewage is treated (excluding septic tanks); or (b) from which treated sewage is discharged onto land or into waters.	12,000 m ³ per day

3. Consultation

The Licence Holder was provided with the draft Amendment Report on 25 May 2023. On 08 June 2023, the Licence Holder requested to change the Premises name to Kwinana Water Resource Recovery Facility. This amendment has been incorporated into the final instrument.

On 17 July 2023, the Licence Holder confirmed there were no further comments.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that a Revised Licence will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.

4.1 Summary of amendments

Table 2 below provides a summary of the proposed amendments and will act as a record of implemented changes. All proposed changes have been incorporated into the Revised Licence as part of the amendment process.
