1. Decision summary

The Delegated Officer has determined to make amendments to licence L6953/1997/8. The amendments are administrative in nature therefore they do not alter the risk profile of the premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This amendment report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the existing licence will remain on the department's website for future reference and will act as a record of the department's decision making.

1.1 Regulatory framework

In amending the licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

1.2 Amendment summary

Licence L6593/1997/8 is held by Shire of Wongan-Ballidu (licence holder) for the Wongan Hills Waste Management Site (the premises), located on Lot 4107 on Deposited Plan 217155 and Lot 350 on Deposited Plan 58302, on Wongan-Koorda Road, in Wongan-Hills.

The premises relates to the categories and the assessed production/design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing licence L6953/1997/8.

The department considers there to be insufficient time to complete a licence renewal prior to the current licence expiry. Therefore, the licence duration will be extended for a short period to ensure the current licence continues to remain in force until a full assessment is able to be completed.

On 30 August 2024 the department initiated an amendment to licence L6953/1997/8. The amendment is limited to extending licence expiry date, amalgamating previous amendment notices, amending the premises boundary, amending typographical errors and revising the licence to the new licensing format.

While conducting the assessment, it was noted that the licence holder was operating outside of the prescribed premises boundary in Lot 351 on Deposited Plan 58302. The Department of Planning, Lands and Heritage (DPLH) was contacted and advised the department that the licence holder had authority to be operating within Lot 351 on Deposited Plan 58302. The premises boundary has been updated as part of this amendment to reflect this.
