Amendment Notice

DWER initiated an amendment to Licence L7084/1997/16 to rectify an administrative error with regards to the licence expiry date in the 2016 Extend Expiry Program which stated licence expiry was 16 June 2019 contradicting the date on the existing licence of 16 June 2020.
