1. Decision summary

The Delegated Officer has determined to make amendments to Licence L7384/1999/8. The amendments are administrative in nature therefore they do not alter the risk profile of the premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This amendment report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the existing licence will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the licence, the department has considered and given due regard to its regulatory framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

2.2 Application summary

Licence L7384/1999/8 is held by Suez Recycling & Recovery (Welshpool) Pty Ltd (licence holder) for the Welshpool Resource Recovery Park (the premises), located at 116 Kurnall Road, Welshpool.

The premises relates to the category and the assessed throughput capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Licence L7384/1999/8.

On 4 June 2024, the licence holder submitted an application to the department to amend Licence L7384/1999/8 under section 59B of the *Environmental Protection Act 1986* (EP Act). The amendment is limited only to updating the name of the licence holder from Suez Recycling & Recovery (Welshpool) Pty Ltd to Veolia Recycling and Recovery (Welshpool) Pty Ltd.

Veolia and Suez merged in March 2022 and the entity name and registered address were updated in the merge. This licence amendment is to update the licence holder name on the licence to reflect this.

In amending the licence, the CEO has:

- Updated the licence to revised licensing format and wording;
- removed any redundant conditions and realigned condition numbers for numerical consistency; and
- · corrected clerical mistakes and unintentional errors.

3. Consultation

The licence holder was provided with the draft amendment report on 1 July 2024. On 2 July 2024 the licence holder waived the comment period.

4. Conclusion

Based on the assessment in this amendment report, the Delegated Officer has determined that an amended licence will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
