1. Decision summary

The Delegated Officer has determined to make amendments to Licence L7817/2006/6. The amendments are administrative in nature and therefore do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the existing licence will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

2.2 Application summary

Licence L7817/2006/6 is held by Sand Queen Gold Mines Pty Ltd (Licence Holder) for the Sand Queen Dewatering Project (the Premises), located at M29/52, M29/233, M29/321, L29/67 in the Shire of Menzies, Western Australia.

The Premises relates to the category 6 mine dewatering and the assessed production capacity under Schedule 1 of the *Environmental Protection Regulations* 1987 (EP Regulations) which is defined in existing Licence L7817/2006/6.

On 23 December 2022, the Licence Holder submitted an application to the department to amend Licence L7817/2006/6 under section 59B of the *Environmental Protection Act 1986* (EP Act). The amendment is limited to extending the licence expiry date, updating the wording of conditions and fixing typographical errors.

3. Consultation

4. Conclusion

The Delegated Officer has determined that an amended licence will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.

In amending the licence, the Delegated Officer has also:

- Updated the structure of the licence to the contemporary format;
- Deleted redundant conditions covered by other legislation to reduce duplication; and
- Revised condition numbers.
