1. Decision summary

The Delegated Officer has determined to transfer licence L7845/2003/7 to Minesite Recycling Pty Ltd. The transfer is administrative in nature therefore they do not alter the risk profile of the premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act). This Amendment Report also documents the transfer made pursuant to section 64 of the *Environmental Protection Act 1986* (EP Act).

The existing decision reports for the licence will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

2.2 Application summary

Licence L7845/2003/6 was held by M8 Sustainable Limited. On the 02 May 2025 the department received an application to transfer the licence to a new licence holder, Minesite Recycling Pty Ltd under section 64 of the EP Act.

Licence L7845/2003/7 relates to the Minesite Recycling (previously M8 Sustainable) premises, located at 42 Kelvin Road in Maddington.

The premises relates to the categories and the assessed production capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing licence L7845/2003/7.

The transfer is limited only to updating the occupier's name, registered business number, registered business address and premises name.

3. Consultation

On 31 July 2025 the licence holder waived the comment period.

4. Conclusion

Based on the assessment in this amendment report, the delegated officer has determined that an amended licence will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
