1. Decision summary

The Delegated Officer has determined to make amendments to Licence L8470/2010/2. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

2. Scope of assessment

2.1 Regulatory framework

In amending the Licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at https://www.der.wa.gov.au.

2.2 Amendment summary

Licence L8470/2010/2 is held by Karratha Environmental Crushing Pty Ltd (the Licence Holder) for the Karratha Environmental Crushing site (the Premises), located on a portion of Crown Lease GE J-287979, Dampier Road, Gap Ridge.

The Premises relates to the category and the assessed production/design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in the existing Licence.

On 8 May 2020, the department initiated an amendment to Licence L8470/2010/2. The amendment is limited to:

- extending the Licence expiry date;
- including the requirement for monitoring of waste inputs and outputs;
- including the requirement for the submission of an Annual Environmental Report; and
- updating condition wording to better reflect condition intent, in line with the current condition format in use by the department.

The requirement for the monitoring of waste inputs and outputs, and the submission of an Annual Environmental Report, is now a standard requirement for inclusion on issued instruments by the department, and will hence be included in the Revised Licence. No additional risk assessment of the Premises has been undertaken.

In amending the Licence, the CEO has:

- updated the format and appearance of the Licence;
- replaced maps of the Premises within the Licence with updated maps;
- deleted the redundant Annual Audit Compliance Reporting form set out in Attachment 1
 of the previous Licence and advised the Licence Holder to obtain the form from the
 Department's website;
- revised Licence Condition numbers, and removed any redundant conditions and realigned Condition numbers for numerical consistency; and
- corrected clerical mistakes and unintentional errors.

3. Consultation

The Licence Holder was provided with the draft Amendment Report on 12 June 2020. The Licence Holder responded on the 23 June 2020 confirming minor outstanding items of information to be correct.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended Licence will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.

4.1 Summary of amendments

Table 1 below provides a summary of the proposed amendments and will act as a record of implemented changes. All proposed changes have been incorporated into the Revised Licence as part of the amendment process.
