1. Decision summary

The Delegated Officer has determined to make amendments to Licence L8501/2010/2. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

2. Scope of assessment

2.1 Regulatory framework

In amending the licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

2.2 Amendment summary

Licence L8501/2010/2 is held by Global Advanced Metals Greenbushes Pty Ltd (licence holder) for the Global Advanced Metals Greenbushes (the premises), located at Maranup Ford Road, Greenbushes WA.

The premises relates to the category and the assessed production/design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing licence L8501/2010/2.

On 16 September 2020, the licence holder submitted an application to the department to amend licence L8501/2010/2 under section 59B of the *Environmental Protection Act 1986* (EP Act). The amendment is limited only to updating occupier's registered business address; and the inclusion of the category and approved throughput on the front page of the licence.

3. Consultation

The licence holder was provided with the draft Amendment Report on 25 September 2020. No comments were received from the licence holder during the consult period.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended licence will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.

4.1 Summary of amendments
