## 1. Decision summary

The Delegated Officer has determined to make amendments to Licence L8513/2010/2 to change the annual reporting period. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The original decision report for the existing licence will remain on the department's website for future reference and will act as a record of the department's decision making.

## 2. Scope of assessment

#### 2.1 Regulatory framework

In amending the licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <a href="https://dwer.wa.gov.au/regulatory-documents">https://dwer.wa.gov.au/regulatory-documents</a>.

#### 2.2 Amendment summary

Licence L8513/2010/2 is held by Shire of Merredin (Licence Holder) for the Merredin Chandler Road Landfill (the Premises), located at Lot 500 on Plan 66111 Chandler Road, Merredin.

On 4 December 2020, the Licence Holder submitted an application to the department to amend Licence L8513/2010/2 under section 59B of the *Environmental Protection Act 1986* (EP Act).

There is no variation from operation activities forming part of the existing licence. The amendment is limited to a change in the annual reporting period, from 2 March - 1 March in the following year, to 1 July - 30 June each year.

In amending the licence, the CEO has also:

- updated the format and appearance of the licence;
- revised licence condition numbers, and removed any redundant conditions and realigned condition numbers for numerical consistency; and
- · corrected clerical mistakes and unintentional errors.

#### 3. Consultation

The Licence Holder was provided with the draft amendment report on 29/03/2021. A reply email confirming no objection to the proposed amendments was received on 30/04/2021.

#### 4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended licence will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
