1. Decision summary

The Delegated Officer has determined to make amendments to Licence L8515/2010/2. The amendments are administrative in nature therefore they do not alter the risk profile of the premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision reports for the existing licence will remain on the department's website for future reference and will act as a record of the department's decision making.

1.1 Regulatory framework

In amending the licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at: https://dwer.wa.gov.au/regulatory-documents.

1.2 Amendment summary

Licence L8515/2010/2 is held by Product Recovery Industries Pty Ltd (Licence Holder) for the Pinjarra Resource Recovery Centre (the premises), located on Part of Lot 11 on Diagram 66827.

The premises relates to the category and the assessed design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Licence L8515/2010/2.

The department initiated an amendment to Licence L8515/2010/2. The amendment is limited to extending the licence expiry date and aligning with the anniversary grant date; renumbering of conditions; typographical errors; updating the format of the licence; and updating definitions as required.

The department considers there to be insufficient time to complete a licence renewal prior to the current licence expiry. Therefore, the licence duration will be extended for a short period to ensure the current licence continues to remain in force until a full assessment is able to be completed.

2. Consultation

The Licence Holder was provided with the draft Amendment Report on 14 October 2024. On 14 October 2024, the Licence Holder waived the comment period and advised the department that the changes to the licence were acceptable.

3. Summary of amendments

Table 1 and Table 2 below provide a summary of the proposed amendments and will act as a record of implemented changes. All proposed changes have been incorporated into the revised licence as part of the amendment process.
