1. Decision summary

The Delegated Officer has determined to make amendments to licence L85727/2011/2. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the Existing works approval will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the works approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <https://dwer.wa.gov.au/regulatory-documents>.

2.2 Application summary

Licence L8572/2011/2 is held by Western Resource Recovery Pty Ltd (Licence Holder) for the Western Resource Recovery Hampton Location (the Premises).

The premises relates to the categories and assessed production capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) defined on the licence. The infrastructure and equipment relating to the premises category and any associated activities are outlined on the licence and are in line with *Guideline: Risk Assessments* (DWER 2020).

On 2 August 2024, the department initiated an amendment to Licence L8572/2011/2. The amendment is limited to:

- correcting typographical error in condition 18 and condition 21;
- correcting condition numbering references within licence conditions; and
- correcting the annual period dates.

3. Consultation

The Licence Holder was provided with the draft Amendment Report on 6 August 2024. Comments received from the Licence Holder on 8 August 2024 have been considered by the Delegated Officer as detailed in Appendix 1.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended works approval will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
