## 1. Decision summary

The delegated officer has determined to transfer licence L8634/2012/1 to Maximore Holdings Pty Ltd. The transfer is administrative in nature therefore does not alter the risk profile of the premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This transfer report documents the amendments made pursuant to section 64(2) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the existing licence will remain on the department's website for future reference and will act as a record of the department's decision making.

## 2. Scope of assessment

### 2.1 Regulatory framework

In transferring the licence, the department has considered and given due regard to its regulatory framework and relevant policy documents which are available at <a href="https://dwer.wa.gov.au/regulatory-documents">https://dwer.wa.gov.au/regulatory-documents</a>.

### 2.2 Transfer summary

Licence L8634/2012/1 is currently held by Advanced Waste Disposal Pty Ltd (licence holder) for the solid waste depot (the premises), located at 14 Glyde Court, Malaga.

The premises relates to the category 62 and the assessed design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing licence L8634/2012/1.

This amendment is limited to the transfer of licence L8634/2012/1 from Advanced Waste Disposal Pty Ltd to Maximore Holdings Pty Ltd.

#### 2.3 Consolidation of Licence

As part of this amendment package the department has consolidated the licence by incorporating changes made under the amendment notices as summarised in Table 1.

The obligations of the licence holder have not changed in consolidating the licence. The department has not undertaken any additional risk assessment of the premises related to previous amendment notices.

In consolidating the licence, the CEO has:

- updated the format and appearance of the licence;
- revised licence condition's numbers, and removed any redundant conditions and realigned condition numbers for numerical consistency; and
- corrected clerical mistakes and unintentional errors.

The full consolidation of licence conditions as they relate to this revised licence are detailed in Section **Error! Reference source not found.**. Previously issued amendment notices will remain on the department's website for future reference and will act as a record of the department's decision making.

#### 3. Assessment

As part of this assessment a review of the legal occupancy of the applicant was carried out to determine if a transfer of licence may occur. A review of the compliance history of any current licenses held by the company was also undertaken.

It has been determined that:

- Maximore Holdings Pty Ltd is a registered and valid company and is therefore a legal entity that can hold a licence under Part V of the EP Act;
- Maximore Holdings Pty Ltd has provided evidence that they are the current landholder of the premises (Lot 24 on Plan 1908);
- The agreement provides authorisation for Maximore Holdings Pty Ltd to operate the solid waste depot on the premises and takeover the premises from Advanced Waste Disposal Pty Ltd; and
- There are no significant compliance matters relating to Maximore Holdings Pty Ltd or its directors that would prevent the granting of this transfer.

#### 4. Conclusion

Based on the assessment in this transfer report, the delegated officer has determined that Maximore Holdings Pty Ltd is a legal entity and a fit competent operator. The Delegated Officer will therefore transfer licence L8634/2012/1 to Maximore Holdings Pty Ltd.
