1. Decision summary

The Delegated Officer has determined to make amendments to Licence L8660/2012/2. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approval remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act) and incorporates all previous amendments authorised for this licence.

All previous decision reports for this licence will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <u>https://www.der.wa.gov.au</u>.

2.2 Amendment summary

Licence L8660/2012/2 is held by FQM Australia Nickel Pty Ltd (Licence Holder) for the Ravensthorpe Nickel Project Tamarine quarry (the Premises), located at Mining Tenement M74/220 Tamarine Road, Jerdacuttup.

The Premises relates to the category 12 assessed production/design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Licence L8660/2012/2.

On 1 December 2020, the department initiated an amendment to Licence L8660/2012/2. The amendment is limited to updating to the new DWER licence format, renumbering of conditions, updating and inclusion of definitions, changing licence version 1 to version 2 to align with corporate databases and removing obsolete licence conditions.

3. Consultation

The Licence Holder was provided with the draft Amendment Report and draft Licence on 16 December 2020. No comment was received from the Licence Holder by 25 January 2021 therefore the Delegated Officer proceeded to grant the amended Licence.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended Licence will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.

4.1 Summary of amendments
