1. Decision summary

The Delegated Officer has determined to make amendments to licence L8757/2013/2. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the existing licence will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

2.2 Application summary

Licence L8757/2013/1 is held by Eco Resources Pty Ltd (licence holder) for the Eco Resources Recycling Transfer Station (the Premises), located at 165 Postans Road, Hope Valley WA 6165.

The Premises relates to the categories and the assessed production/design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing licence L8757/2013/2.

On 19 November 2024, the licence holder submitted an application to the department to amend licence L8757/2013/2 under section 59B of the *Environmental Protection Act 1986* (EP Act). The amendment is limited only to amending the registered business address on the licence to align with the company's ASIC details.

3. Consultation

On 5 February 2025 the licence holder waived the comment period.

4. Conclusion

Based on the assessment in this amendment report, the Delegated Officer has determined that an amended licence will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
