1. Decision summary

The Delegated Officer has determined to make amendments to Licence L8851/2014/1. The amendments are administrative in nature therefore they do not alter the risk profile of the premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision reports for the existing licence will remain on the department's website for future reference and will act as a record of the department's decision making.

1.1 Regulatory framework

In amending the licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at: https://dwer.wa.gov.au/regulatory-documents.

1.2 Amendment summary

Licence L8851/2014/1 is held by the Shire of Irwin (Licence Holder) for the Dongara Transfer Station (the Premises), located at Dee Street, Port Denison.

The Premises relates to the categories and the assessed design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Licence L8551/2014/1.

The department has initiated an amendment to Licence L885/2014/1. The amendment is limited to extending the licence expiry date and aligning with the anniversary of the grant of the licence, updating the lot description and other minor updates as detailed in Table 1.

2. Consultation

The Licence Holder was provided with the draft Amendment Report on 11 October 2024.

On 17 October 2024 the Licence Holder waived the comment period.

3. Summary of amendments

Table 1 below provides a summary of the proposed amendments and will act as a record of implemented changes. All proposed changes have been incorporated into the revised licence as part of the amendment process.
