1. Decision summary

The Delegated Officer has determined to make amendments to Licence L8857/2014/1. The amendments are administrative in nature therefore they do not alter the risk profile of the premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

1.2 Amendment summary

Licence L8857/2014/1 is held by the Shire of Cranbrook (Licence Holder) for the Frankland Waste Management Facility (the premises), located at Racecourse Road, Frankland River.

The premises relates to the category and the assessed design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Licence L8857/2014/1.

The department initiated an amendment to Licence L8857/2014/1. The amendment is limited to extending the licence expiry date; typographical errors; updating wording of conditions deletions of definitions, etc.

2. Consultation

The Licence Holder was provided with the draft Amendment Report on 28 October 2024. The licence holder did not provide comment on the draft package.

3. Summary of amendments
