#### 2. Amendment Description

The Onslow Waste Transfer Station is located on Part Lot 500 Onslow Road, Onslow WA, being part of Lot 500 on Plan 401881. The Existing Licence (L8872/2014/1) was issued 26 March 2015, licencing the Premises as a Category 57 (used tyre storage) and 62 (Solid waste depot).

On 19 June 2019, the Shire of Ashburton submitted an application for an amendment to the current Licence. The Licensee requested an amendment to the wording of Table1.3.2 with respect to the maximum number of hours which putrescible waste may be stored onsite. The Licence currently limits the period for which putrescible waste may be stored onsite to 72 hours. This amendment will extend this period to 96 hours in order to accommodate the Shire of Ashburton's logistical requirements.

The Delegated Officer has also decided to extend the licence duration a further 5 years from 29 March 2020 to 28 March 2025. As the Department of Water and Environmental Regulation (DWER) has not yet completed the development of guidelines on the full reassessment of renewed licenses, the Delegated Officer intends to extend the licence expiry date for the premises. A full reassessment of the premises licence and operations will be considered on a risk-basis within the context of DWER's Licence Review Programme.

This amendment is made pursuant to section 59 of the *Environmental Protection Act 1986* (EP Act) to amend the Licence issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

This amendment also incorporates changes to the formatting and style of the licence. The obligations of the Licence Holder have not changed in making this amendment. During this amendment, DWER has not undertaken any additional risk assessment of the Premises.

The Delegated Officer has:

- Amended wording of Table1.3.2 to increase the time limit for which putrescible waste may be stored onsite from 72 to 96 hours;
- Extended the expiry date from 29 March 2020 to 28 March 2025
- Corrected prescribed premises boundary coordinates;
- Updated to the Premises Map to current aerial imagery; and
- Corrected clerical mistakes and unintentional errors.

### 2.1 Amendment history

This the first issued amendment to Licence L8872/2014/1. An application for an amendment was submitted by the Shire of Ashburton on 17 July 2017, but this was subsequently withdrawn.

#### 3. Decision

Putrescible waste received onsite is received and sorted within the constructed putrescible waste bunker, or stored within enclosed or covered transfer trailers in accordance with condition 1.3.3 and the process limits prescribed in Table 1.3.2 of L8872/2014/1. These measures are intended to minimise potential odour emissions from the premises and any potential impact on nearby sensitive receptors. In addition, condition 2.7.1 has been included on the Licence to ensure that any generated odour does not affect the amenity of persons not on the Premises. The Licensee has previously advised that it inspects all loads delivered to the putrescible waste bunker for highly odourous materials, and remove them from the Premises at the earliest possible occasion.

A review of DWER's Incidents and Complaints Management System (ICMS) has revealed no

previous incidents or complaints in relation to odor management at the premises.

The nearest residential and sensitive receptors, and their distance from the Premises boundary, are outlined in Table 2. The Delegated Officer considers the separation distance sufficient to inform the risk of odour impacts as not foreseeable.

The Delegated Officer has therefore determined that the increase in storage time for putrescible waste will not alter the risk profile of the premises and a detailed risk assessment for the proposal is not required.

On the basis of the above, the Delegated Officer has determined that that an amendment be granted to amend the wording of Table 1.3.2. The wording of the process limits for putrescible waste in Table 1.3.2 has been amended to change the original process limit of "Shall not be
