1. Decision summary

The delegated officer has determined to make amendments to licence L9011/2016/2. The amendments are administrative in nature therefore they do not alter the risk profile of the premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This amendment report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the existing licence will remain on the department's website for future reference and will act as a record of the department's decision making.

1.1 Regulatory framework

In amending the licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <https://dwer.wa.gov.au/regulatory-documents>.

1.2 Amendment summary

Licence L9011/2016/2 is held by Alkina Holdings Pty Ltd (licence holder) for the Alkina Postans Road Facility (the premises), located at 243 Postans Road, HOPE VALLEY WA 6167.

The premises relates to the category and the assessed design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing licence L9011/2016/2.

On 30 August 2024, the department initiated an amendment to licence L9011/2016/2. The amendment is limited to extending licence expiry date, renumbering of conditions, typographical errors and updating condition wording and definitions.

2. Consultation

The licence holder was provided with the draft amendment report on 9 September 2024. The licence holder did not provide comment on the draft package.

3. Summary of amendments

Table 1 below provides a summary of the proposed amendments and will act as a record of implemented changes. All proposed changes have been incorporated into the Revised licence as part of the amendment process.
