## **Amendment Report**

#### **Amendment description**

DWER initiated the amendment to Licence L9054/2017/1 to correct an administrative error to the Premises name that occurred as a result of the recent transfer of the Licence from Tox Free Australia to Veolia Environmental Services (Australia). The amendment is limited only to an amendment to the Premises name. No changes to the aspects of the original licence relating to Category 61 have been made. After consultation with the Licence Holder, DWER intends to amend the Premises name from *Tox Free Tom Price* to *Tom Price Liquid Waste Facility*.
